Japanese Business Establishments in India - 2017


The Embassy of Japan and JETRO updated the List of Japanese Business Establishments in India, as of October 2017, with the cooperation of Japanese Chamber of Commerce and Industries in India, The summary of the result is as follows:

- 1. The total number of Japanese companies registered in India, as of October 2017, is 1,369.
- 2. The total number of Japanese business establishments in India, as of October 2017, is 4,838.
- 3. Over the last one year, the number of companies has increased by 64 (5% growth) as compared to 1,305, as of October 2016. Similarly, the number of establishments has increased by 248 (6% growth) as compared to 4,590, as of October 2015.
- 4. In Haryana and Maharashtra, the number of Japanese companies and establishments increased more than that in any other states in the survey 2017. Manufacturing sector accounts for the half of the Japanese companies and a third of the Japanese business establishments in India. Further, more and more Japanese companies have entered the service sector as a new trend. On the other hand, some companies downsized their business or turned non-Japanese due to restructuring and change of ownership.

About this list

The Embassy of Japan in New Delhi, Consulates General of Japan in Mumbai/ Chennai/ Kolkata/ Bengaluru, and JETRO, have jointly compiled the list, with the cooperation of Japanese chambers of commerce and industries in India. The findings are as follows:

- (1) The **total number of Japanese companies registered in India is 1,369**, with an increase of 64 companies (5% growth) as compared to 1,305 in October 2016.
- (2) The **total number of Japanese business establishments in India is 4,838**, with an increase of 248 establishments (6% growth) as compared to 4,590 in October 2016.

(Please note that in case a company has business operations at multiple sites, each of them has a separate entry in this list. Kindly refer to the following "definition" for further details).

<u>Definition of "Japanese Business Establishment" in India</u>

In principle, any of the following is considered as a Japanese Business Establishment in this survey:

- 1. Liaison Office/ Branch Office etc. of a Japanese company in India (as a foreign entity)
- 2. Indian Subsidiary (Wholly Owned/ Joint Venture) of a Japanese company, in the form of:
 - (A) Head Office, (B) Manufacturing Unit, or (C) Branch Office/ Business Office etc.
 - * Franchisees or dealers are not counted under this category.
 - * In case of JVs, only those companies where the Japanese company has more than 10% shareholding, are counted under this category.
- 3. Business Enterprise founded in India by Japanese national(s)
- ♦ This list is arranged in alphabetical order as per the location.
