It is my great honour and pleasure to attend the opening ceremony of Otsuka JIM today. I would like to offer my heartfelt congratulations to all of you on this auspicious occasion. Japan-India relations have never been stronger than they are now. In the last one year, SriCity Japanese companies' JIM, Bellsonica JIM, and Maruti Suzuki Haryana JIM have been added to the growing tally, along with this Otsuka JIM. The program imparts key Japanese production concepts such as KAIZEN, 5S, work skills and ethics, to equip the young, talented Indian workers to become middle management engineers and future shop floor leaders.
