Japanese Business Establishments in India – 2021

The Embassy and Consulates-General of Japan in India and JETRO updated the List of Japanese Business Establishments in India as of October 2021 with the cooperation of Japanese chambers of commerce and industries in India. The summary of the result is as follows:

1. The total number of Japanese companies registered in India as of October 2021 is 1,439. The number slightly decreased as compared to 1,455 in 2020. The total number of Japanese business establishments in India as of October 2021 is 4,790. It has decreased by 158 (3.19%) as compared to 4,948 in 2020.
2. While Delhi and Karnataka exhibited a slight increase in the number of Japanese companies, Maharashtra and Haryana exhibited a decrease. While there was an increase in the number of establishments in such sectors as “Transport and Mail Service” and “Finance and Insurance Industry”, “Construction” and “Lodging Industry and Restaurant” exhibited a decrease. Manufacturing sector accounts for about half of the total Japanese companies and about a third of the Japanese business establishments in India. The total number of establishments decreased due to the closure of offices, corporate restructuring, change of ownership, etc.
3. The number of Japanese companies in India rose by 134 from 1,305 companies in 2016, demonstrating a steady growth during the course of five years.

About this list

The Embassy and Consulates General of Japan in India, and JETRO, have jointly compiled the list, with the cooperation of Japanese chambers of commerce and industries in India. The findings are as follows:

(1) The **total number of Japanese companies registered in India is 1,439**, marked the slight decrease compared to the previous year (1,455 in October 2020).

(2) The **total number of Japanese business establishments in India is 4,790**, with an decrease of 158 establishments (3.19% decline) as compared to 4,948 in October 2020

(Please note that in case a company has business operations at multiple sites, each of them has a separate entry in this list for "business establishments". Kindly refer to the following "definition" for further details).

Definition of "Japanese Business Establishment" in India

In principle, any of the following is considered as a Japanese Business Establishment in this survey:


1. Liaison Office/ Branch Office etc. of a Japanese company in India (as a foreign entity)
2. Indian Subsidiary (Wholly Owned/ Joint Venture) of a Japanese company, in the form of:
(A) Head Office, (B) Manufacturing Unit, or (C) Branch Office/ Business Office etc.

** Franchisees or dealers are not counted under this category.*

** In case of JVs, only those companies where the Japanese company has more than 10% shareholding, are counted under this category.*



(Note 1): Oct 2010 onwards, being based on the defined criteria of the Japanese Business Establishments in India as (1) Head office, (2) Factory, and (3) Branches etc also regulate to include establishment without regular-basis Japanese staffs., it is observed a slight decline of Japanese Business Establishments in some areas.

(Note 2): In order to capture the business scenario of Japanese Companies in India more precisely, all the Business Establishments (except franchisee and dealer) irrespective of regular-basis Japanese staffs are taken into consideration Oct. 2013 onwards. Consequently, some areas show a significant increase in numbers.

(Note 3): The increase in the number of Japanese business establishments during the one year (October 2013 to October 2014) under the survey is very large, mainly due to the following reasons: In case where a Japanese company forms a JV with an Indian partner, the newly formed JV will also have the already established direct branch offices of that Indian partner, which will result in the immediate increase of the total number of business establishments. There are several such cases found during the survey, especially in insurance and transport sectors. There were also quite a number of Japanese business establishments which have not been captured in our previous surveys.

(Note 4): The number of establishments in Delhi and Haryana is mentioned separately for 2013, 2014 and 2015.

(Note 5): The number of Japanese companies and establishments in 2013 and 2014 has been revised at the time of survey for 2015.
